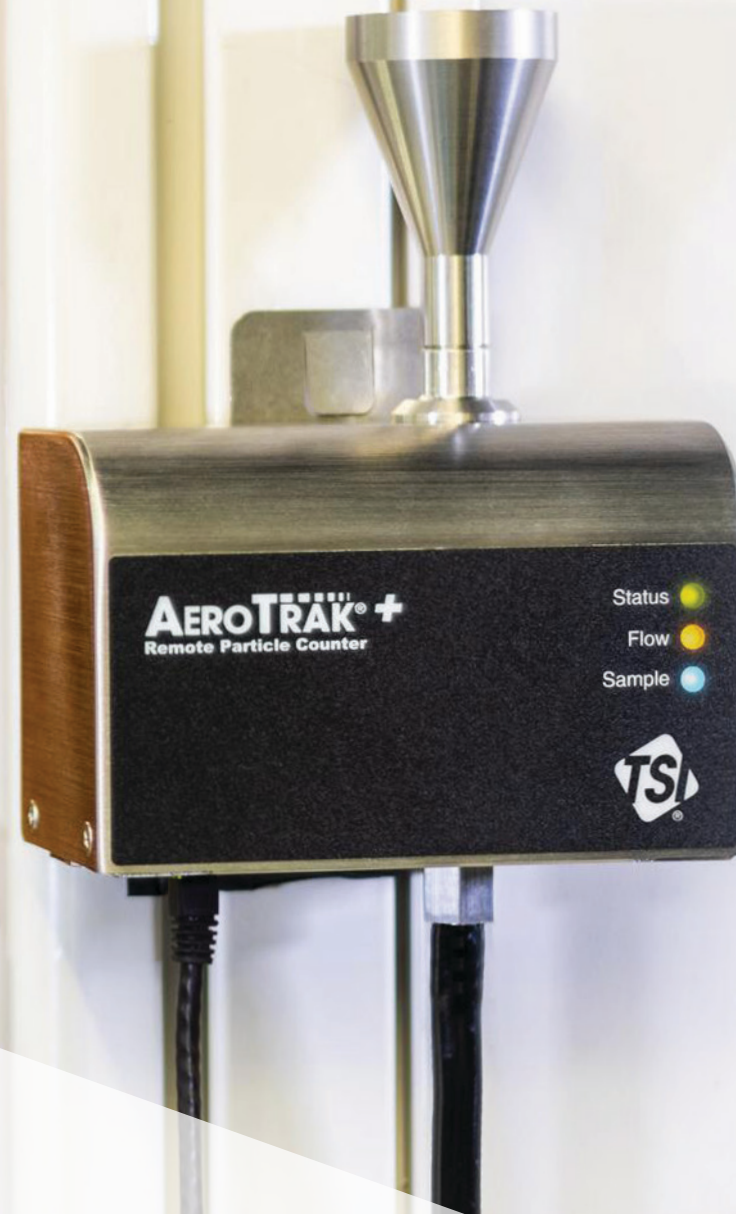

An intuitive, user configurable interface means visibility of real-time data. Single mouse click access to historical data and report generation leads to reduced operator training, rapid data access and improved process control.

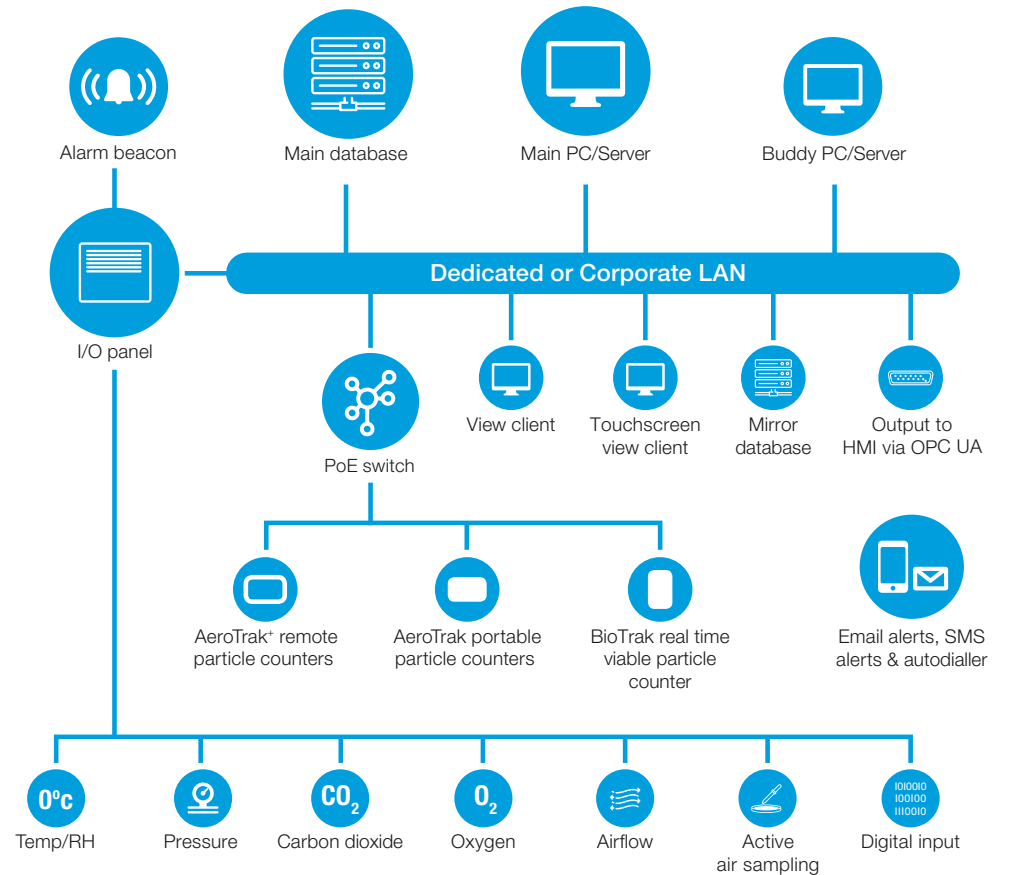
## Mapping
