

graph. 8. Mixtures that do not contain the statement "Mixture for use in tattoos or permanent make-up" shall not be used for

tattooing purposes.

9. This entry does not apply to substances that are gases at temperature of 20 °C and pressure of 101,3 kPa, or generate a vapour pressure of more than 300 kPa at temperature of 50 °C, with the exception of formaldehyde (CAS No 50-00-0, EC No 200-001-8).

Where the placing on the market or use may not be exclusively as a medical device or an accessory to a medical device or an accessory to a medical device, the requirements of Regulation (EU) 2017/745 and of this Regulation shall apply cumulatively.
